Is this opportunity available to you?

Your project must be either Indigenous-Led or Indigenous-Partnered.

To be an **Indigenous Led** organization, we will consider that the leadership of your group, and those leading the proposed work, are Indigenous.

To be an **Indigenous-Partnered** organization, you must be partnering in this work with an Indigenous-Led organization or group. Is this opportunity available to you? To be Indigenous-Led or Partnered, we are also looking at what values and protocol guide your work, which relationships/accountabilities are in place, etc.

There is no requirement to be:

- A qualified donee or registered non-profit society;
- A First Nation government; or
- A specifically law-focused organization;



What kind of projects are eligible?

All projects need to be related to law

Projects must be related to law, whether to Canadian law or legal systems, or Indigenous law or legal systems.

In the application, you will be asked to identify which mandate area your application best aligns with and how you see it aligning.

Mandate areas:

LAW REFORM LEGAL RESEARCH LEGAL EDUCATION LEGAL AID LAW LIBRARIES What kind of projects are eligible?

All projects must be BC-based

Applicants are only eligible if they operate (or intend to operate) in BC and/or for the benefit of people living on the lands known as BC.





What opportunity should you apply for?

You may apply to multiple!

Purpose:

to uplift and support the work of Indigenous People, organizations and communities to address the impact of colonial systems and institutions, while restoring power to their communities and creating connection

•Cedar Grant (4-Year Grant, \$250,000 per year, total \$1,000,000)

•Willow Grant (2-Year Grant, \$125,000 per year, total \$250,000)

•Gathering (One-time, \$250,000)

Weaving Justice Grants Call: Grant Types

• Sweetgrass Grant (One-time Grant, \$100,000)

There are two types of Sweetgrass Grants. Both are one-time grants of \$100,000.

- **Development:** for the development of capacity, ideas and infrastructure to advance future intended initiatives or programs
- Land & Law: for discrete land-based opportunities where communities study and share their Indigenous laws and practices in ways that advance the priorities of this Grants Call

Community Justice Grants Call

Purpose:

to support community justice initiatives that are Indigenous-Led and are part of a community's strategy to transform systems of law and justice in ways that are informed by Indigenous protocols, practices, values and ceremonies

Community Justice Grants Call

Priorities:

- Improving Experience (at any point in the justice continuum)
- Reviving Indigenous Systems (of community justice)
- Reducing Harm (including reducing stigma and lateral violence)



Community Justice Grants Call

Values:

- Transformation
- Indigenous Values
- Community Accountability



Community Justice Grants Call: Grant Types There are no specific grant types within the Community Justice Grants Call.

Applicants may request any funding amount that aligns with the scope of their intended project, up to a maximum.

For example, you could apply for a \$100,000 for one year of work to lead community consultations and develop an idea for a future project.

At most, you may apply for up to \$1,000,000 (\$250k per year for 4 years) through this opportunity.

Stage 2 of Application Process (for Cedar Grants & Community Justice Grants) This info is on our FAQ under Application Process

What does Stage 2 - Oral Conversation entail?

Stage 2 only applies to Cedar Grants and Community Justice Grants.

Grant-seekers will be invited to speak with Foundation staff via Zoom. There will be two Foundation Staff in attendance and one to three representatives of the applicants' organization or group.

Grant-seekers will be provided with the same questionnaire designed to guide the conversation one week before the meeting.

The Foundation invites Grant-seekers to make space in the conversation to communicate the proposed path and/or impact of their work in any way that is meaningful to them, which could be in the form of cultural expressions, song, story, testimony, or others. This will be the first opportunity to get to know one another and determine potential alignment and to seek clarity where needed for everyone involved.

Both Oral Conversation and Written Supplement Applicants may be asked to submit a full budget.

All applicants will be informed of any outstanding requirements with at least three weeks' notice.

Decisions for Cedar Grants Call and Community Justice Grants Call will be communicated in December 2024.

What does Stage 2 - Written Supplement entail?

Stage 2 only applies to Cedar Grants and Community Justice Grants.

Grant-seekers will be invited to complete a questionnaire within a set deadline no sooner than three weeks after the questionnaire was provided.

This will be the Grant-seekers' opportunity to communicate the proposed path and/or impact of their work to the Foundation in any way that is meaningful to them, which could include artwork, video or other visual media in addition to their written answers.

Applicants who choose to submit a Written Supplement will also have opportunities to speak to Foundation staff to seek clarity where needed.

Both Oral Conversation and Written Supplement Applicants may be asked to submit a full budget.

All applicants will be informed of any outstanding requirements with at least three weeks' notice.

Decisions for Cedar Grants Call and Community Justice Grants Call will be communicated in December 2024.



Submitted Questions

Question: Can one organization apply to both the Weaving Justice Grants Call and the Community Justice Grants Call with different projects?

Question: Would a non-qualified donee organization led by an Indigenous hereditary group be eligible to apply? **Question**: Can either of these grants support legal consultation such as legal fees for legal challenges related to land protection?

Question: Can this funding be used for human trafficking prevention and awareness/MMIWGP initiatives?

Question:

What are the reporting requirement expectations?

Annually, one report for the grant, consisting of both financial reporting (in writing) and narrative activity reporting (either in writing or provided orally) at the end of each year of the grant cycle.

The Foundation may also convene interested grantees for shared learning opportunities and celebrations, and attendance at these gatherings may stand in for narrative activity reporting.
